COMMERCIAL**

(Class 3, 5, 6 & 9 buildings, including a boarding house/guest house/hostel >300m<sup>2</sup>, accommodation for the aged/disabled/children, school, office used for professional or commercial purposes, shop, restaurant, showroom, service station, public assembly building, health-care facility, entertainment venue, temporary structure and the like and additions thereto.)
